For what purpose do we treat your personal data?

The ICAB treats the information provided to us for the management of training services and with the possibility of processing the ERASMUS + grant from the European Commission and sending you information about our services and ICAB activities that are not directly related to the provision of the training service.

How long will we keep your data?

These data are kept until the fulfillment of the contractual obligations or until the consent is revoked except the data that are necessary to comply with legal and statutory obligations such as the limitation periods for possible legal responsibilities based on the treatment performed.





What is the legitimacy for the treatment of your data?

The legal basis for the treatment of your data is the execution of the contract for the provision of the training service.

The data will be transferred to international law firms and the European Commission and universities with their prior consent. The legal basis for sending by post and electronically, to students and associates, information about our services and activities of the ICAB that are not directly related to the provision of the requested training service is the legitimate interest due to its statutory status. The legal basis for sending by post and electronically, to non-members or non-members, information about services and activities of the ICAB that are not directly related to the provision of the requested training service is the legitimate interest due to to the provision of the requested training service is the consent.

The categories of data that are treated are:

Identification data, codes or identification keys, postal or electronic address, financial, academic and professional information.

What are your rights when you provide us with your data?

- Anyone has the right to obtain confirmation about whether the ICAB is processing personal data that concerns him, or not.
- The interested persons have the right to access their personal data, as well as to request the rectification of inaccurate data or, if necessary, request its deletion when, among other reasons, the data is no longer necessary for the purposes that were collected.
- In certain circumstances, interested parties may request the limitation of the processing of their data, in this case we will only keep them for the exercise or defense of claims.
- In certain circumstances and for reasons related to their particular situation, the interested parties may oppose the processing of their data. The ICAB will stop processing the data, except for compelling legitimate reasons, or the exercise or defense of possible claims.
- Interested parties may request the portability of their data in automated support to another of the responsible in the cases of treatments allowed by the RGPD.
- At the time of cancellation of data, we will only keep them blocked in compliance with legal obligations.
